

GUISELEY CRICKET CLUB CONSTITUTION

1. Name

The club will be called *Guiseley Cricket Club* and is affiliated to the YCB & ECB.

2. Aims and objectives

The aims and objectives of the club will be:

- To offer coaching and competitive opportunities in cricket
- To promote the sport of cricket in the local community
- To ensure a duty of care to all members of the club
- To provide all its services in a way that is fair and equal to everyone
- To ensure that all present and future members receive fair and equal treatment

3. Membership

Membership should consist of officers and members of the club.

All members will be subject to the regulations of the constitution and by joining the club will be deemed to accept the regulations and codes of conduct that the club has adopted.

Members will be enrolled in one of the following categories:

- full member
- junior member
- family member
- life member
- social member

4. Membership fees

Membership fees will be set annually and determined by the Cricket Club Committee.

Fees will be paid by annual subscription.

5. Officers of the club

The officers of the club will be:

- Chairman
- President
- Secretary
- Junior Chairman
- Treasurer
- Club Captains
- Marketing Co-Ordinator
- Club Welfare Officer
- any other relevant position

Officers will be elected annually at the Annual General Meeting.

6. Committee

The club will be managed through the Cricket Club Committee which will meet on a monthly basis and will comprise the Officers of the Club and any other members elected at the AGM.

The Committee will be responsible for adopting new policy, codes of conduct and rules that affect the organisation of the club.

The Committee will have powers to appoint sub-committees as necessary and appoint advisers as necessary to fulfil its business.

The Committee will be responsible for disciplinary hearings of members who infringe the club rules/regulations/constitution.

The Committee will be responsible for taking any action of suspension or discipline following such hearings.

7. Finance

All club monies will be banked in an account held in the name of Guiseley Cricket Club.

The Club Treasurer will be responsible for the finances of the club.

The financial year of the club will end on 30th September.

An audited statement of annual accounts will be presented by the Treasurer at the Annual General Meeting.

Any cheques drawn against club funds should hold the signatures of the Treasurer plus up to two other officers.

8. Annual General Meetings

Notice of the Annual General Meeting (AGM) will be given by the Club Secretary. Not less than 21 clear days' notice to be given to all members.

The AGM will receive a report from officers of the Committee and a statement of the audited accounts.

Nominations for officers of the Committee will be sent to the Secretary prior to the AGM.

Elections of officers are to take place at the AGM.

All members have the right to vote at the AGM.

The Committee has the right to call Extraordinary General Meetings (EGMs) outside the AGM. Procedures for EGMs will be the same as for the AGM.

9. Discipline and appeals

All complaints regarding the behaviour of members should be submitted in writing to the Secretary.

The Committee will meet to hear complaints within 7 days of a complaint being lodged. The committee has the power to take appropriate disciplinary action including the termination of membership.

The outcome of a disciplinary hearing should be notified in writing to the person who lodged the complaint and the member against whom the complaint was made within 7 days of the hearing.

There will be the right of appeal to the Committee following disciplinary action being announced. The committee should consider the appeal within 7 days of the Secretary receiving the appeal.

10. Amendments to the constitution

The constitution will only be changed through agreement by majority vote at an AGM or EGM.
